#### Mobile Crisis Program

- Reminder of program mission
- LA DMH
  - TCMHA Mobile Crisis Care will be part of LA County DMH's response
  - Coordinating with LA County DMH is ongoing to determine details of implementation and operation
- Process map
  - More processes to develop include triaging and what to do in case of opioid emergency
  - Feedback from Karissa (PV Hospital) regarding voluntary transport and coordination with hospital: Request for clarification on type of hospital—depends on the situation. PV Hospital is a trauma center and medical emergencies are the priority. Concerned about 5150 hold. There is no guarantee of psychiatric services or bed availability. It is important to communicate with client about the experience of going to the hospital.
  - TCMHA team will consult real-time registry of available psychiatric beds.
  - Feedback from Jill (PV Hospital) regarding minors: It is important to communicate to parents/guardians that they must remain with the child. The child experience in the emergency room/trauma center is different. The longer to hold the child, the longer it takes to transfer. Just because they are in a hospital does not mean they will receive immediate psychiatric services. There is a high volume of kids being brought in from school, and they wait for days.
  - TCMHA will consider developing a youth-specific MCC process.
  - The hope is that Mobile Crisis Care program as an intervention with triage and response will decrease visits to the hospital.
- Additional Crisis Care Mobile Units grant funding
  - \$1.5M request submitted for personnel costs/time for triage and dispatch, relationship building and coordination, outreach and engagement, training and technical assistance, equipment and supplies, and marketing






## Referrals Received by District/School

In March 2022, Tri-City Mental Health Authority (Tri-City/TCMHA) accepted a Mental Health Student Services Act (MHSSA) grant from the California <u>Mental Health Services Oversight and Accountability Commission (MHSOAC)</u> in an effort to meet the following aims:

- To promote school mental health as a prime opportunity to reach and serve at-promise children, families and neighborhoods;
- To reach children, youth, and their families in an environment where they are comfortable and that is accessible; and
- To help students succeed.

Through this MHSSA grant project, Tri-City is fostering stronger schoolcommunity mental health partnerships that can leverage resources to increase access to collaborative, culturally-relevant, coordinated, family-driven, community and school-based services for **at-promise youth and young adults (ages 25 and under) in Pomona, Claremont, and La Verne.** This includes foster youth, youth who identify as LGBTQ+, and youth who have been or at risk of being expelled or suspended from school.

The MHSSA project launched in December 2022 and collaborative partners include Pomona Unified School District, Claremont Unified School District, Bonita Unified School District and The School of Arts and Enterprise.



Tri-City is following a "no wrong door" philosophy, removing barriers to timely access to care, and providing youth and young adults with mental health services on school campuses.
